What You Told Us About TA Delivery and Resources

Start with the basics and prioritize a systems-level approach.

Resources should be digitized and accessible from a mobile phone.

TA needs to be practical and prioritize bringing people in similar roles together.

TA should be low burden and easy to fit into the day.

TA should be interactive and build relationships across states, tribes, and territories.

Make communities of practice as topic specific as possible.

Organize TA to align with program maturity and regional similarities.

PROGRAM CAPACITY BUILDING:

This area encompasses resources and activities to assist Pediatric Mental Health Care Access (PMHCA) and Maternal Depression and Related Behavioral Disorders (MDRBD) grant recipients with core implementation support, including strategic planning, infrastructure building, communications, and sustainability planning.

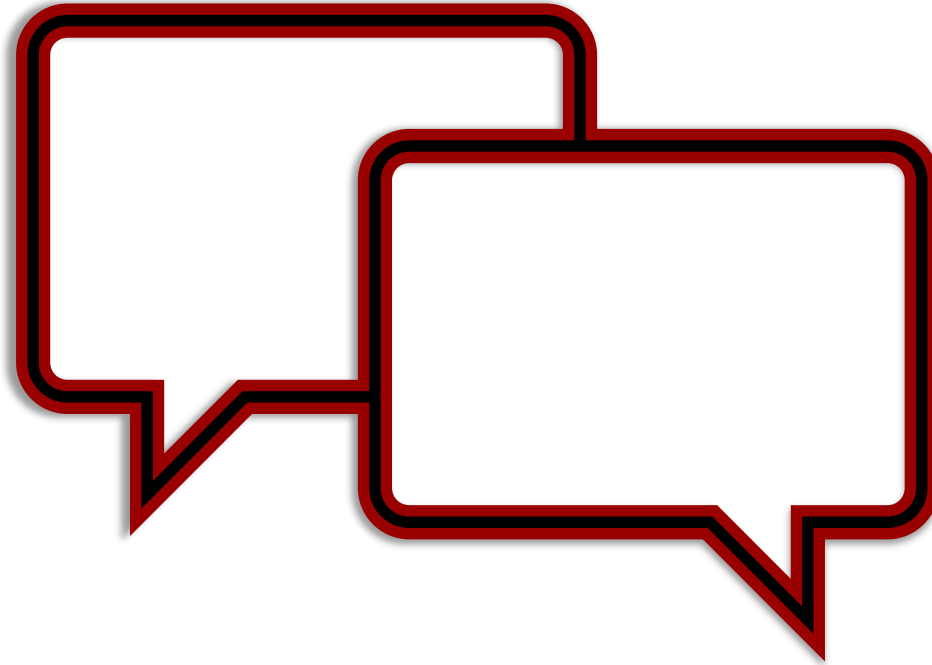
Toolkits, patient and family education materials, tip sheets and pocket guides, awareness posters
