

Hello PMHCA Awardees!



It is my pleasure to formally invite you to engage in new technical assistance (TA) activities supported by the MCHB TA Innovation Center. We are delighted to be partnering with JBS International, Inc. to better support your implementation needs.

The PMHCA program has grown tremendously since the Health Resources and Services Administration (HRSA) made the first awards in 2018. We now have 50 awardees, including 43 states, the District of Columbia, U.S. Virgin Islands, Republic of Palau, Federated States of Micronesia, Commonwealth of the Northern Mariana Islands, Chickasaw Nation, and Red Lake Band of the Chippewa Indians. We hope to further expand the program this fiscal year (FY).

We are so proud of your efforts to support providers to effectively care for children and youth with behavioral concerns. Your reach and impact grow each day. According to FY 2021 data from 21 PMHCA programs, over 6,700 primary care providers (PCPs) enrolled in statewide or regional PMHCA programs, and 6,400 PCPs received training on a range of pediatric behavioral health topics. Pediatric primary care providers who contacted PMHCA teams served over 8,200 children and adolescents, with approximately 3,700 living in rural and underserved counties. That's impressive! Yet we know that building, implementing, and growing a PMHCA program is complex.

It is our hope that the MCHB TA Innovation Center will accelerate your implementation and provide expanded support through activities such as:

- **Fostering ongoing exchange** of effective practices, resources, and peer-to-peer learning and mentorship
- Connecting awardees to subject matter experts and resources to meet program-specific needs
- Developing resources to expand the knowledge base about PMHCA
- Identifying promising innovations and program models
- **Supporting capacity to engage** in data collection, program monitoring, evaluation, and continuous quality improvement activities

• Facilitating shared learning and collaboration across recipients and with external partners

As the program has grown incrementally over the past 4 years, one constant has been the cohort approach to addressing emerging issues, promoting effective approaches, and generously sharing resources with each other as you have built the PMHCA infrastructure in your states, Tribes, and nationally. The MCHB TA Innovation Center can help you more comprehensively support each of these areas. I hope you take advantage of these resources. Please also share with your HRSA Project Officer any other ways in which the MCHB TA Innovation Center or MCHB can support you and your PMHCA program.


