#### A Phone Consultation Call Line to Support SBIRT in Pediatric Primary Care

Screening, Brief Intervention, and Referral to Treatment (SBIRT) is recommended as a routine part of pediatric primary care. Yet managing patients who test positive for mental illness is challenging. To address this problem, the state of Massachusetts created a call line staffed by pediatric substance misuse treatment specialists. This phone line provides consultations for PCPs and access to a behavioral healthcare provider specially trained in managing adolescent substance use. <u>Read more.</u>

## Suicide: Blueprint for Youth Suicide Prevention
