

- 1. Establish provider-to-provider perinatal mental health consultation line
- 2. Refer more complex patients for evaluation
  - Provide one-time consultations by PROMISE subject matter experts
- 3. Connect to supportive/adjunctive services and ongoing care
  - Embed PROMISE Care Navigator into DHS clinics for enhanced connection to care
- 4. Build program with potential to scale across California

### New Statewide MMH-SUD Program

- Phone and E-consultation—build off the success of CoPPCAP, PMHCA Program
  - Single phone number for access and administrative support through a lifespan approach to community consultation programs for mental health and substance use
  - One-time, face-to-face consults via telehealth when needed
- Educational focus on health equity, culturally responsive, and trauma-informed care
  - Through ECHO and Black Health Initiative CAPE simulation trainings
  - Support connection to peer mentors with lived experience through partnerships with Alma Program, MotherWise, and Hard Beauty
- Healthy Equity Expert Panel of Psychologists—part of the core team in the first year
  - Inform development to address health disparities in access and maternal mortality

#### TOP GOALS OF THE PROGRAM

- Increase the number of providers trained in perinatal behavioral health, including frontline health care practitioners, public health providers, and providers who predominately serve individuals who experience health disparities
- Increase utilization of real-time psychiatric consultations and care coordination support services, especially utilization by providers who serve individuals who experience health disparities (e.g., race, ethnicity, socioeconomic, Medicaid, rural, or frontier)
- Develop and implement a robust communications plan to increase PCP enrollment, PCP utilization of all KCC program components, and collaborate with key partners on program sustainability











### Goals of CHAMP for Moms

- Establish a statewide perinatal mental health and SUD care telehealth access program
  - This program will be heavily based on our existing CHAMP (CHild Access to Mental health and Psychiatry) program.
- Provide real-time psychiatric consultation, care coordination support services, and culturally and linguistically appropriate training to maternity care providers and clinical practices in MS
  - Frontline and maternity care providers will be prioritized, including obstetricians/gynecologists, doulas, nurse midwives, psychiatric and substance use care providers, behavioral healthcare providers, pediatricians, and adult primary care providers.

#### **Top Goals of Program:**

As part of the state of **Missouri's Maternal Mortality Prevention Plan**, we plan to implement a hub-and-spoke model Perinatal Psychiatry Access program with a focus on rural and medically underserved areas to improve care for pregnant and postpartum persons and to do the following:

- Increase routine behavioral health screening for pregnant and postpartum persons
- Increase routine detection, assessment, brief intervention, treatment, and referral of maternal mental health conditions through evidence-based practices
- Increase access to treatment and recovery support services for pregnant and postpartum persons that are culturally and linguistically appropriate
- Increase behavioral health training and education for frontline medical providers

### Texas MMHSUD Goals



**Goal 1:** Build the capacity of Texas' perinatal workforce to enable routine MMHSUD screening for pregnant and postpartum women, especially women living in underserved communities and women living in under-resourced rural areas

**Goal 2:** Increase access to real-time psychiatric consultation and substance use disorder screening, treatment, and recovery support resources for the perinatal workforce. Pregnant and postpartum women will be able to obtain in-person or telehealth care from providers in the Be Well Texas Recovery Network and the Be Well Texas Clinic.

**Goal 3:** Increase access to trauma-informed, culturally, and linguistically appropriate psychiatric or substance use disorder treatment and recovery support services for pregnant and postpartum women

#### Characteristics:

- Expand existing PeriPAN as newly funded MMHSUD
- Implement statewide
- Focus on women with SUD

## Texas Learning Objectives



- MMHSUD efforts tend to start with MH. Texas wants to learn about innovative strategies and/or lessons learned that can help expand Texas PeriPAN to be more inclusive of SUD.
- Texas want to understand how states have streamlined the telementoring user experience to reduce confusion and frustration, especially when using multiple telementoring platforms.
- With an understanding that many women with MMHSUD delay engagement with perinatal providers, Texas wants to learn how to ensure that the training and telementoring provided is relevant to and meets the needs of multiple provider types that engage with pregnant and postpartum women.
- Texas wants to learn how to shift treatment of SUD from an acute care model to a chronic disease care model and integrate SUD under the umbrella of medical care.
