As of September 30, 2023, 12 states have been awarded funding for both the Pediatric Mental Health Care Access (PMHCA) program and the Screening and Treatment for Maternal Mental Health and Substance Use Disorders (MMHSUD) program. This newsletter presents examples of their collaborative efforts, highlighting awardee experiences and successes in aligning the PMHCA and MMHSUD programs in their states. Additionally, a summary is included from the peer-to-peer sharing session on aligning programs, hosted by the Technical Assistance Innovation Center (TAIC) on July 20, 2023, with information about challenges and lessons learned. ## Kansas Programs

To enhance the sustainability of Kansas' psychiatric access programs [Kansas Connecting Communities \(KCC\)](#) and [Kansas Kids Mental Health Access Program \(KSKidsMAP\)](#), the Kansas Department of Health and Environment (KDHE) utilized HRSA supplemental funding for a collaborative infrastructure

consolidation project. KCC is transitioning data to the University of Kansas Health System's REDCap system, which aligns with KSKidsMAP's existing system, fostering integration. The consolidation includes a unified Consultation Line number, streamlining access for pediatric primary care and perinatal practitioners in Kansas. The KDHE explored re-branding to present a cohesive identity for both programs, resulting in a shared logo.

Moving forward, the project aims to create outreach materials using the new logo, such as PowerPoint templates, flyers, and brochures. Information will be disseminated statewide through established relationships with professional organizations. The KDHE anticipates increased awareness and utilization of psychiatric access program support services, enhancing quality care availability, especially for vulnerable populations in rural areas.



## Missouri Programs

[The Missouri Child Psychiatry Access Project \(MO-CPAP\)](#) and the Perinatal Psychiatry Access Program (MO-PPAP)

plan to collaborate to provide a continuum of support for Missourians from pregnancy through their 22nd birthday. Both program's vision and mission are to increase mental and behavioral health care access. Since the two programs are implemented by the same team at the University of Missouri Department of Psychiatry, there are opportunities for mutual recruitment of providers, marketing, and cross-educational opportunities. Additionally, the programs will share the same call center, providing a single contact point allowing providers to consult with a child and adolescent or perinatal psychiatrist. The two programs will collaborate to share a comprehensive database of mental and behavioral health resources accessible to care coordinators as they support both populations' resource and referral needs.

## **Evaluation of the Michigan Clinical Consultation and Care Program: An Evidence-Based Approach to Perinatal Mental Healthcare**

Mood and anxiety disorders affect pregnant individuals and their families at increased rates throughout the perinatal period. Geographic, financial, and social barriers often preclude adequate diagnosis and treatment. The aim of this manuscript is to describe the consultation and care arms of the Michigan Clinical Consultation and Care (MC3) program, a statewide program designed to facilitate access to perinatal mental health care for OB/Gyn patients, and to describe the participants engaged in the program, examine the predictors of participant retention, and provide preliminary data regarding participants' mental health outcomes. ## **Incorporating Recognition and Management of Perinatal Depression Into Pediatric Practice**

Perinatal depression is the most common obstetric complication in the United States, with prevalence rates of 15% to 20% among new mothers. Untreated, it can adversely affect the well-being of children and families through increasing the risk for costly complications during birth and lead to deterioration of core supports, including partner relationships and social networks.
