#### **Individual TA**

#### Resource Sharing

- Sent toolkits and engaged subject matter experts for additional information and ideas
- Provided lists of relevant entities (e.g., School-Based Health Centers [SBHCs]) and assessment resources

#### Facilitated Discussions and Coaching Calls

- Conducted drop-in office hours on topics such as working with SBHCs and data and evaluation
   Scheduled follow-up coaching calls based on specific needs and interests
- Made peer-to-peer connections for mentorship, resource sharing, and collaboration

#### Follow-Up and Implementation Support

- Followed up on previous coaching calls, assisting with planning and implementing initiatives such as needs assessments and website launches
- Discussed various methods for gathering information from stakeholders, such as listening sessions, focus groups, and surveys

#### Specific, Targeted Interventions

- Assisted with integrating consult lines and focusing outreach efforts, particularly in response to new legislation
- Helped programs explore technology solutions and collaborate with external vendors for evaluation and central triage lines



#### Individual TA Provided to PMHCA

#### Key topics/takeaways covered in individual TA

- Provider training
  - Use Extension for Community Healthcare Outcomes (ECHO)-type model to increase attendance at trainings.
- Provider registration/enrollment
  - Find a provider "champion."
- Engaging SBHCs
  - Conduct a needs assessment for school professionals.
  - Navigate care coordination between primary care providers (PCPs) and SHBCs.
- Obtaining CMEs/CEUs for educational events
  - Partner with a university.
- Engaging emergency departments
  - Use the EIIC Implementation toolkit.
- Data and Evaluation
  - Data collection platforms:
    - \* Examples are Trayt, Salesforce, REDCap, and Excel.
  - Create a more robust evaluation tool.







# Individual TA Provided for Maternal Mental Health and Substance Use Disorder (MMHSUD) Awardees

#### Key topics/takeaways covered in individual TA:

- Use of doulas in the MMHSUD program
  - Provide general mental health training, such as Mental Health First Aid, to doulas.
- Onboarding a new medical director
- Implementing a peer support component
  - Postpartum Support International is a resource for training around specialized support.
- Reimbursement for services
- Examples of needs assessments/gaps analysis
- Connection to another program with success using Redcap
  - Colorado and Kansas are examples of a couple of the programs using this platform.
- Job description for a social worker
- Messaging and strategies for engaging physicians
- Metrics and monitoring of outreach activities
  - Track the number of consultations.
- Provider enrollment





### **Community of Practice (CoPs) 2024**

#### Newly awarded PMHCA and MMHSUD programs – Key takeaways from each session

- February 27, 2024: Kick-Off Meeting Review of Implementation Toolkit
  - The toolkit includes information on developing the core team and advisory committee,
     partnerships, conducting a needs assessment and determining core components of the program.
  - The toolkit has a sample training schedule, suggested content, learning vignettes, and links to resources such as job descriptions, needs assessments, marketing materials, guidebooks, and workplans.
- March 26, 2024: Establishing a Core Team With Standards of Practice
  - Resources, such as job descriptions, can be found in the Implementation Toolkit.
  - National Network of Child Psychiatry Access Programs and Lifeline for Moms both have basecamp sites with resources for PMHCA and MMHSUD awardees.
  - A medical director or equivalent position is needed to oversee programmatic aspects.
- April 30, 2024: Partnerships to Impact Success of a Behavioral Healthcare Access Program
  - Programs may incorporate home visiting for screening results and referral options.
  - MMHSUD programs often partner with Postpartum Support International or their state perinatal quality collaborative.
  - Convey a message of "We're here to help you" when recruiting partners.









### **Communities of Practice 2024 (cont.)**

- May 28, 2024: Determining Core Components and Data Metrics
  - Examples of data collection systems being used include Trayt, REDCap, Salesforce, and Excel.
  - Perinatal support programs typically include telephone and face-to-face consultation, resource referral, and TA.
  - Operationalizing screening practices is needed for integrating mental health care into pediatric visits.
- June 25, 2024: Developing and Implementing an Enrollment Process With Strategies for Retention
  - Use of the word sign-up or registration may be more effective than enrollment.
  - Some MMHSUD programs include doulas, social workers, and nurses in addition to physicians.
  - Provide an incentive, such as continuing education units/credits, for providers to participate.
- July 30, 2024: Lessons Learned and Plans for the Future
  - Awardees shared lessons learned throughout the CoPs.
    - Guided discussion co-facilitated by programs funded in 2022
    - ❖ Support in identifying next steps in program development





#### **Peer-to-Peer Sharing Sessions**

- November 8, 2023: Messaging and Marketing Programs to Providers
  - Building strong foundational relationships with providers through face-to-face meetings
  - Creating region-specific marketing campaigns
  - Recruiting physician champions and including testimonials in promotional materials
  - Beginning with an ECHO series before the call line is available to allow the provider network to become familiar with the program
- March 11, 2024: Aligning PMHCA and MMHSUD Programs
  - Using cloud-based systems for communication and coordination
  - Creating universal outward-facing messaging and marketing campaigns
  - Ensuring that incoming data metrics have program-specific identifiers
  - Educating providers about the differences between pediatric and perinatal services



- Creating tailored training programs to address legal obligations such as mandated reporting
- Partnering with FQHCs to allow them to use their limited capacity for more critical care needs
- Understanding the cultural context of potential partners and adapting approaches accordingly
- Integrating the ECHO model with EDs
- July 17, 2024: Culturally Relevant Services



### 2024 Annual Meeting Networking Session

#### Key takeaways:

- Overcoming barriers
  - Cross train with other programs to address issue of limited staff.
  - Engage rural practitioners by hosting conferences.
- Partnerships
  - MMHSUD partners include doula associations, home visiting staff, and perinatal quality collaboratives.
  - PMHCA partners with Department of Education and family-based groups.
  - Meet partners where they are and use food as a trust-building tool.
- Provider engagement
  - Distribute swag/promotional items.
  - Personalize outreach such as in-person meetings and handwritten notes.
  - Organize CME events.
  - Use advisory committee members to give presentations about the program.







### 2024 Annual Meeting Networking Session (cont.)

- PMHCA and MMHSUD alignment
  - Emphasize co-branding and cross-training staff.
  - Improve sustainability and demonstrate comprehensive program coverage.
- Sustainability
  - Leverage partnerships with medical schools.
  - Bill Medicaid.
- Research and evaluation
  - Conduct follow-up surveys after consultation for rapid feedback.
  - Promote resources on program websites with tools providers trust.
- Maternal substance use disorder (SUD)
  - Review hospital policies on mandated reporting and training, as they can vary.
  - Include hesitant or resistant providers of interest at stakeholder meetings.
  - Market the program by emphasizing that health centers can bring more patients to their practices if they train providers in perinatal mental health and SUD.





### **2024 Site Visits: Key Takeaways**

#### Republic of Palau – March 2024

- Previously developed materials already exist, such as Colorado Care Guides, Virginia Mental Health Access
  Programs provider guidebook, AAP's Bright Futures, American Academy of Child and Adolescent
  Psychiatry's Parent Medication Guide, AAP's Suicide Blueprint for Youth Suicide Prevention, and Seattle's
  Partnership Access Line's Washington Care Guides.
- Consider a program such as "Sources of Strength" in the high school setting; it is a model focused on suicide prevention that can engage the Youth Coalition.

#### Federated States of Micronesia – March 2024

- Use remote applied behavior analysts in the program when having difficulty finding local providers who work with autism spectrum disorder.
- Train community health workers to ensure they have knowledge of PMHCA and can effectively market services to providers and the community.

#### West Virginia – June 2024

- While the call line is primarily for PCPs, consider secondary audiences such as ED providers and school-based health providers.
- Establish a joint call line process with MMHSUD and PMHCA to help with staffing and operational support
- Look for providers who demonstrate interest and skill to be your "champions."


### **TA Portal: Accessing Resources and Event Recordings**

Event Calendar

Navigate to the 'Event Calendar' workspace along the lefthand navigation pane. Then toggle from list view to calendar view by clicking on the calendar icon. This will allow you to easily view upcoming events.

Tasks are used to create events in the calendar. You can view events on the 'All pending' tab or in the 'Tasks' tab.

Click on the event in the calendar to view details.





#### **TA Portal: Discussion Board**


Navigate to the 'Discussion Board' workspace along the lefthand navigation pane. This will show the list of discussion topics which can also be accessed by selecting 'Files' in this workspace.

Select a discussion topic that you want to respond to.

Discussion will take place in the pane to the right of the discussion topic document. To join the discussion, go to the 'Comments' section and start typing your response or question in the "Join the conversation' section.

Tag or alert other people in the workspace by using the '@' symbol followed by their name. Always use @mentions to reply to another user's comment.








#### **TA Portal: Discussion Board (cont.)**

To add a discussion topic, select the folder where you want to add a discussion topic.

On the righthand side of the page, select "Note."


On the note, enter a title for your topic. Then add your discussion question or prompt. Hit "Save" when you are finished. This will save your new discussion topic to the folder.

To get the discussion started, you can enter a comment in the Comments section, using @<username> to mention other users. @ mentions will send that user a notification in BHP-TAP and via email.

### TA Portal: Submitting a TA Request (cont.)


From the "Downloads" folder on your computer, select the "TA Request Form for TA Portal" document and open the file.

Complete the TA Request Form by typing in your information under each section of the form.

Save the file to your computer.

On the lefthand navigation pane, select "Files" again. Find the folder with your Awardee name and select it.

In the actions hub on the right side of the page, select "Upload files."







### TA Portal: Submitting a TA Request (cont.)

Follow the instructions on the screen to upload your file.

Once the file is uploaded, select "Done."


Your file is now uploaded.

#### Important final step:

To notify the TA Team of your request, open your newly uploaded file.

On the righthand side of the page in the "Comments" section, start typing @technical until you see the "Technical Assistance (TA) Team" user populate. Select this user.

Send the message by selecting the arrow icon.
